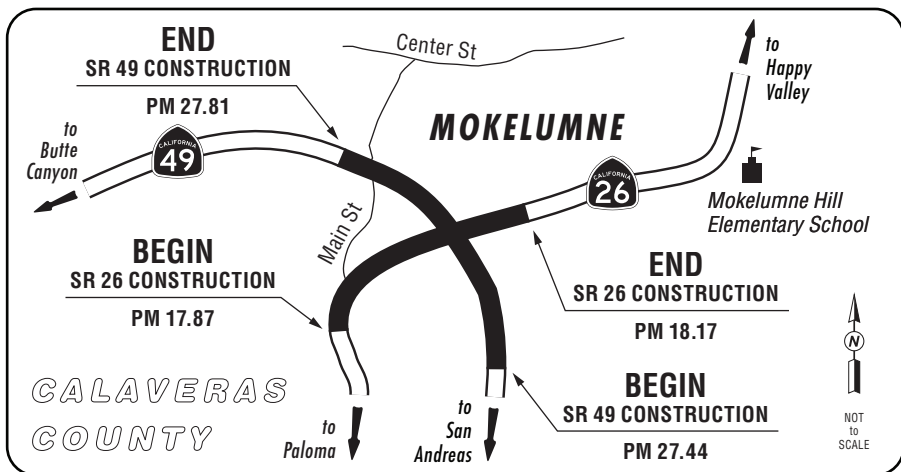
### Highway 26/49 Intersection Control Improvement Project

#### WHAT IS BEING PLANNED?

The California Department of Transportation (Caltrans) proposes to improve the safety of the intersection at State Route 26 and State Route 49 in Calaveras County in the census-designated town of Mokelumne Hill. A collision report from the California Highway Patrol identified a pattern of broadside collisions at this intersection. Two alternatives—a Build Alternative and a No-Build Alternative—are being proposed. The Build Alternative proposes to build a roundabout, and the No-Build Alternative would leave the intersection in its current condition.

#### WHY THIS PUBLIC NOTICE?

Caltrans has studied the effects this project may have on the environment. Our studies show the project will not significantly affect the quality of the environment. The report that explains why is called an Initial Study with Proposed Negative Declaration. This notice is to inform you of the preparation of the Initial Study with Proposed Negative Declaration and of its availability for you to read and comment on. A public open house will be held to give you an opportunity to talk about certain design features of the project with Caltrans' staff before the final design is selected.
